Standing United in Opposition of the Prenatal Nondiscrimination Act

In Our Own Voice joined with the community of reproductive health, rights and justice organizations and submitted testimony to the House Judicial Subcommittee on the Constitution and Civil Justice, April 14.

The all male subcommittee heard testimony on the misleadingly titled Prenatal Nondiscrimination Act, or PRENDA. Once again, Rep. Trent Frank (R-AZ) has introduced this bill that targets women of color who seek abortion healthcare services. It is yet another obvious attempt to limit abortion access by imposing "criminal penalties on anyone who knowingly or unknowingly assists with an abortion" sought on the basis of sex-selection or race-selection. Hours before the hearing Rep. Judy Chu (CA-27), Rep. Sheila Jackson Lee (TX-18) and Rep. Loretta Sanchez (CA-46) joined with reproductive health, rights and justice advocates for a press conference on Capitol Hill to publicly denounce the Prenatal Nondiscrimination Act.

In Our Own Voice Calls Out the Hypocrisy of the Anti-Choice Movement

In Our Own Voice promoted a week long ad campaign, March 14-18, calling out Rep. Sean Duffy’s (R-WI) suggestion that members of the Congressional Black Caucus aren’t “standing up for their communities” if they support abortion access.

“Congressman Duffy is just one example of a politician whose “pro-life” agenda ends after birth. He and his colleagues repeatedly vote against black women and children—from Medicaid expansion and minimum wage increases to access to contraception, medically-accurate sex education and affordable access to abortion. The anti-choice agenda puts black women at risk, and it’s long past time to end the hypocrisy,” said Marcela Howell, founder and Executive Director of In Our Own Voice

The campaign included homepage takeovers on the websites of major Washington, D.C. publications, including *The Hill*, *Politico*, and *Roll Call*.
