# **Marcela's Call to Action**



Last week, In Our Own Voice: National Black Women's Reproductive Justice Agenda made history. I had the privilege of testifying to members of the House Committee on Oversight and Reform about state efforts to undermine access to abortion. I was joined by Fatima Goss Graves, President and CEO at the National Women's Law Center, Dr. Colleen McNicholas, Chief Medical Officer at Planned Parenthood of the St. Louis Region and Southwest Missouri, and Jennifer Box of St. Louis, Missouri. My

<u>remarks</u> addressed how the lack of access to abortion and other reproductive health care services impacts Black, Latinx, AAPI, and Native and Indigenous women, transgender and gender non-binary people, LGBTQ people, low-income individuals, people in rural communities, disabled individuals, youth, and immigrants - all those living with intersecting marginalized identities.

This was the first time I've <u>testified</u> before a House committee. *In Our Own Voice* is five years old and we've been doing a lot of work on several issues, including abortion access, so when we got the call from the committee staff about being a witness, it was very validating for us. Ultimately, my hope is that the message I conveyed demonstrated that these barriers to reproductive health care impact all of us, that we all deserve to be empowered to make our own decisions about our bodies and our lives, and that it is time for this country to trust Black women. I am grateful to have had the opportunity to advocate for better reproductive health care a change by <u>contacting your representatives</u> today. Let them know that health care is a human right.

### Moving Beyond ICPD to a Comprehensive Vision for Reproductive Health, Rights, and Justice


This year marks the 25th anniversary of the International Conference on Population and Development and the 25th anniversary of the Reproductive Justice Movement. On Oct. 29, the Center for Health and Gender Equity (CHANGE) and Ipas hosted the "Moving Beyond ICPD" webinar that featured our Founder and President, Marcela Howell. The host organizations coordinated the webinar to generate solidarity among Sexual and Reproductive Health and Rights (SRHR) and Reproductive Justice advocates working on U.S. domestic and global policy. Marcela drew attention to the importance of addressing all issues that might impact a person's sexual and reproductive health, including the intersections of race, gender, and class. A collective vision for Sexual and Reproductive Health, Rights, and Justice must include a more comprehensive understanding of the individuals we are advocating for. The "Moving Beyond ICPD" webinar was a great step toward creating and implementing this vision.

# **Following Our Fellows**

The Next Generation Leadership Institute fellows at Lincoln University, Shamya Hutchinson and Jenai Patrick, presented the *Walk for a Cause: Fashion Show*, a creative collision of fashion and advocacy that promoted awareness of domestic violence and breast cancer. The purpose of the fashion show was to display the ways that art and creative expression can be a powerful vehicle for RJ activism. Our fellows at Spelman University, Zhana Bishop and Emily Laurore, hosted "So You Have A Law Degree: Now What?" earlier this month to equip students with



ways to apply the Reproductive Justice framework into their practice as future lawyers. Sequoia Ayala, JD., MA., Policy and Advocacy Program (PAP) Manager at our partner organization, <u>SisterLove, Inc.</u> served as the keynote speaker and shared her inspiring story of being a first-generation college graduate attending law school while pregnant with her first child. And over at Hampton University, Aman Tune and Michyah Thomas hosted "Voting Through a Reproductive Justice Lens." Their event was a wrap-up conversation following the Nov. 5 election in Virginia. Students were excited to reflect on what they deemed a successful election and all the ways that Reproductive Justice informs their decisions when voting.



The Next Generation Leadership Institute is designed to provide a leadership pipeline specifically for the Black women's Reproductive Justice movement. The Institute is a two-year paid fellowship program that serves as a formal pipeline for training activists on Reproductive Justice and the intersectional issues that impact the lives of Black women, femmes, and girls. Fellows are selected from HBCUs and are trained in advocacy, community organizing, and strategic communications to become young leaders in the Reproductive Justice movement.


